Sl. No.	The school is directed to ensure that:
1	The total number of sections of the school shall be restricted to 15 only. Any further increase in sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by e laws and subject to the availability of infrastructure and room size of 500> sqr ft.
2	School is required to add more books in the library and upgrade the library with recommended library collection and Information Communication Technology Infrastructure as per SoP dated 04.10.2022 (circulation 11/2022). School is directed to upload the compliance on SARAS portal within 03 months.
3	The school has not arranged the mathematics lab as per Board's SoP with sufficient seating and proper storage facilities. The school shall upgrade the Maths lab as per the circular no. 11/2022 and upload the compliance on SARAS portal within 3 months.
4	School is directed to make drinking water facilities at each floor as per Board's guidelines under Affiliation Bye Laws. At present the drinking water facilities is available on alternate floors. School shall make provision on each floor and shall upload the compliance on SARAS portal within 3 months.
5	The school shall ensure the training of its teachers from CoE, Pune and to upload compliance on saras porta within 03 months.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school.
 In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt.
 from time to time. The school will also abide by the conditions prescribed, if any, by the State Government
 concerned.
- The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
- 8. The school shall not remove the documents and videography links in the mandatory disclosure section of its
- The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
